

CONTRACT AGREEMENT

THIS AGREEMENT, made this 11th day of December 2024, between **CITY GOVERNMENT OF DAGUPAN** (hereinafter called the "Entity") and **ED-MART TRADING** (hereinafter called the "Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PROCUREMENT OF VARIOUS CONSTRUCTION MATERIALS AND EQUIPMENT FOR CITY ENGINEER'S OFFICE USE, DAGUPAN CITY** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **THREE HUNDRED FIFTY-EIGHT THOUSAND TWO HUNDRED SIXTY-ONE PESOS ONLY (PhP358,261.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **THREE HUNDRED FIFTY-EIGHT THOUSAND TWO HUNDRED SIXTY-ONE PESOS ONLY (PhP358,261.00)** or such other sums as may be ascertained, the **ED-MART TRADING** agrees to execute and delivery within **THIRTY (30) CALENDAR DAYS** in conformity with the provisions of this **CONTRACT AGREEMENT** in all respects.
4. The **CITY GOVERNMENT OF DAGUPAN** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


